- 7) Player Development  
Update – BC Hockey Summer camp proposal  
Hope to hear back by July 31<sup>st</sup> for final pricing. BC Hockey proposed \$395 per kid, SOMHA countered with \$50 per player, capped at 40 players per level. BC Hockey came back at \$195 per kid.

- 9) Sunbowl Renovation  
Chris met with Osoyoos and Grant Montgomery about renovation of Sunbowl arena. Grant donated his time to provide conceptual drawings; expansion to west end of rink, 30x24 with dressing room on bottom floor, storage and multi-purpose room on top floor. Access from exterior. The town has \$25k put aside to do a feasibility study to be completed approx. end of 2018. The town will wait until then to see what is required to get Sunbowl up to date and

recommend we wait until that study is completed.

The town has a long-term plan to expand dressing all rooms, however they felt minor hockey looking at expanding out the back could be considered and suggested other parties could be approached to help with cost. If all parties are interested, they could apply for grants to try to assist with funding the project.

President was contacted by a group looking for a letter of support for a facility to be built outside of Oliver/Osoyoos properties. The board supports the President writing a letter of support.
